The core module of this package is The Master Internal Policy on Data Protection and Information Security – a high level document which defines your key internal governance and objectives regarding data protection and information security. This document is completed by the Data Processing Regulation, which sets forth the most important rules regarding data protection and defines in particular: (i) data processing principles which your employees must abide by when handling personal data; (ii) processes for engaging sub processors; as well as (iii) the core requirements pertaining to security, transfer of data to third countries, data subject rights, etc.

Depending on your needs and priorities, you can either opt to obtain all or part of the following additional products:

- Data Retention Policy [CHF 1,500 excl. VAT]: sets out storage duration (under Swiss law) for your documents and information in order to comply with data minimization requirements.
- DSAR Guidelines [CHF 650 excl. VAT]: defines your internal processes to response to Subject Access Requests (SAR). You will also get template answers to respond to individual individuals, and a template DSAR log file to register the requests you receive and the actions you have undertaken.
- Information Security Policy [CHF 1,500 excl. VAT]: defines the principles and basic rules for information security management.
- Information Sensitivity Policy [CHF 500 excl. VAT]: classifies the information processed by the company according to set criteria and define general obligations applicable to the handling of each category of information.
- Incident/Data Breach Response Plan [CHF 1,500 excl. VAT]: sets out the company's incident-response processes and procedures, including for data breach notification.
- Other: to be defined depending on your needs.

Process and Deliverables
